Letter from our President

Alex Londen

I talk about production a lot in these articles. It makes sense; production is what we do. We are an agent and customer focused company whose main objective is to grow the Final Expense market through increased sales. Whoever I'm talking to, be it home office associates, agents, vendors, or partners, one of my main topics of conversation is always this month's production numbers and trends.

Something that I don't hit on as much, but has equal importance, is persistency. We can write all the new business in the world, but if it doesn't stick, we all suffer. The consumer doesn't get the protection they need, the agent gets a chargeback, and the company loses money as the cost to issue the policy is significantly more than a few months' premium.

COVID has been terrible in nearly every respect, but it led to one interesting phenomenon. Our persistency not only hit record highs, but it also blew past our previous records. In fact, there were months where 7th month persistency was more than 5% higher than company averages over the previous decade.

While the increased persistency levels are welcome, nobody expects them to remain this high in the long term. What we are now seeing is the direct result of the real and rational fear that accompanies a pandemic and a mortality event such as COVID.

As time goes on and the world moves forward, people will naturally get more comfortable with the risks COVID presents. Not to say that COVID isn't serious, because we know it is, but the fear that sent entire nations into lockdown has indeed passed. Vaccines, natural immunity, and treatments are offering huge subsets of the population protection against the worst outcomes going forward.

As we continue adapting to a new sense of understanding regarding the risks of COVID, we expect to see persistency levels come down. It is only natural, and it is nothing to fear. At the same time, I do not believe there is any reason we should take our previous averages as normal. We can do better, and we should. Higher persistency means more people protected in the market, larger paythru checks for you, and a much stronger, long-term financial outlook for everyone.

I've heard from one of our longtime business partners that he believes persistency is made or broken at the time of sale. A quick, high-pressure sale will certainly lead to a fast NTO, while a planned out and custom-tailored presentation will make someone a lifetime customer. I believe there is wisdom in that logic.

But I also think there are other factors. Our numbers show that policyholders who complete and submit the FCGS A/B forms have average persistency that is roughly 10% higher than policyholders who don't. There is no other variable that I am aware of that has such a strong impact on overall persistency, and it is a relatively easy thing to complete. This is further proof of the immense value offered by our partnership with FCGS and I encourage you to help your customers complete these forms at the time of sale.

Finally, on an unrelated note, like so many, I am stunned and saddened by the events taking place in Ukraine. As well as the immense tragedy that comes with unprovoked war, the world now must deal with a heartbreaking humanitarian crisis as the attack against Ukraine continues. I urge you all to stay up-to-date with these current events and donate even a small amount to the multiple charities and groups assisting innocent civilians with the attack on their sovereign nation.
